DETAILED DESCRIPTION AND / SPECIFICATIONS	<p>The Mandela Bay Development Agency (MBDA) hereby invites suitably qualified service providers to submit quotations for the restoration of an existing cross and the manufacture and installation of a new cross, along with accompanying lighting features as detailed below.</p> <p>Scope of Work</p> <p>1. Restoration of the Existing Cross</p> <p>The existing cross (approximately 3.5m x 1.5m x 100mm thick) with a damaged Jesus Christ cement figurine must be:</p> <ul style="list-style-type: none"> • Removed from its current location at St Mark and St John Anglican Church, Park Side, Port Elizabeth. • Restored to a "good-as-new" condition. Restoration must include: <ul style="list-style-type: none"> ○ Repair of the cross and figurine. ○ Treatment, sealing, and finishing with epoxy/paint and varnish to ensure durability and protection against the elements. • Re-installed at St Peter's Church Ruins, located at the intersection of Pointers Lower Valley Road and South End, Port Elizabeth. <ul style="list-style-type: none"> ○ The cross must be securely mounted on a stainless-steel bracket concreted into a suitable plinth.

- The mounting system should allow the cross to be securely bolted in place. (stainless steel bolts)

2. Installation of Lighting for Restored Cross

- Install a **new floodlight** with a galvanized steel vandal-proof cage to illuminate the cross at night with white light.
- Establish a **power supply and sub-distribution board (sub-DB)** near the cross.
- Install a **daylight switch** to control the lighting automatically.

3. Manufacture and Installation of a Duplicate Cross

- **Manufacture a duplicate cross** similar to the restored cross (3.5m x 1.5m x 100mm thick) but **without the Jesus Christ figurine**.
- **Install the duplicate cross** at **St Mark and St John Anglican Church, Park Side, Port Elizabeth**.
- Apply the same treatment, sealing, and finishing as the restored cross.

4. Installation of Lighting for Duplicate Cross

- Install a **floodlight with a galvanized steel vandal-proof cage** to illuminate the duplicate cross at night with white light.
- Establish a **power supply and sub-DB**, including a **daylight switch**, to control the lighting automatically.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
