The Facility will be operated as a coffee shop.</p> <p>The MBDA will provide a fully fitted kitchen with accompanying storage space and cooking utensils with built in cupboards, fridge, coffee machine and washing facilities.</p> <p><u>The space for lease is at the St Peters precinct, a heritage site with a church ruin, overseeing the PE harbour, Inner City and South End. The site consists of:</u></p> <ol style="list-style-type: none"> 1. St Peters church ruin. 2. A timber deck with 3 Modular units 3. Coffee shop 4. Curio shop/ Tourism 5. Literature room 6.
